Since being established in April 2023 the ASC has carried out the following events in its commitment to engage in stakeholders

In June 2023 the school had a sports day that activity encourages all parents and guardians of the Children to attend in the sports filed behind the school. The event was well attended.

In July the school also had an end of year fair. At the fair there was the usual fundraising events organized by the PTA and staff. £400 pounds was raised by raffles etc. prizes were donated from Prezzo, Van Pelts, forest school, football clubs, the cinema, Corn Exchange and more.
